What is Mind the Gap Effort?

- Prisoner Reentry Initiative
- Three year grant project (9/1/09 8/31/12)
- Funded in part by Federal 1115 Grant
- Partnership between CSED, DOC, G/ES, MFFN, AAFS, Hennepin and Ramsey Counties

Goals

- Build collaborative partnerships
- Improve information sharing
- Train and educate professionals who serve offenders;
- Provide specialized child support case management services to offenders

Expected Outcomes

- Best practices
- Improved paternity testing procedures for inmates
- Improved interface between PRISM and DOC computer system s
- Production of case summary data sheet

Department of Corrections Role

- Participant identification and tracking
- Streamline genetic testing of inmates
- Increase frequency of data exchange
- Expand data provided in interface
- Develop case summary document

MFFN Role

Minnesota Fathers and Families Network

- Coordinate Steering Committee
- Facilitate Kick-off and training events
- Conduct program evaluation

Evaluation

- Process Evaluation
- Outcome Evaluation
- Outcome evaluation will be based on:
 - Pre and post comparison among individual participants
 - Comparison to fathers who were eligible but did not enroll in Mind the Gap
 - Fathers in MCORP control group

Evaluation Indicators

- Key indicators for outcome evaluation:
 - Child support
 - Fathering
 - Recidivism

Role of the Child Support Officer

- Communicate regularly with case manager
- Review for application of SHLIF strategies
- □ Get the order right and keep it right
- Maintain coding for evaluation requirements

What works with this population?

- Work to build trust
- Acknowledge their rights as fathers
- Offer referrals for collateral services
- Reinforce good behavior
- Demonstrate that you want obligor to succeed

Case Management

■ Intensive 1 on 1 services that include:

- Development and Monitoring
- Monthly Fatherhood Plans which motivates goal setting
- Connection to Child Support
- Mentoring

Employment services

- Weekly Job Clubs
- E.R.T.- Employment Readiness Training

Parenting Classes

12 week curriculum that includes:

- Child Development
- Child Guidance
- Family Management
- Personal Development
- Health and Safety
- Co-Parenting

Goodwill/Easter Seals Resources

- Basic Computer Trainings
- Construction, retail, and automotive skills training
- Employment Counseling
- Housing search assistance
- Referral to "Bridging"

Other services offered

- Transportation assistance
- Clothing support
- Professional clothing support
- Mental Health Services Therapy
- Substance abuse support through referrals
- Legal services for those who qualify through Central Minnesota Legal Services

Barriers

- Previous lifestyle
- Stigma that they cannot be trusted
- Addiction
- Resentment of the Judicial System.
- Shame
- Belief that their children are better off without them.
- Belief that they will never, no matter what they do, get the opportunity to be part of their children's life.


Successes

- One client called me to ask for my help because he was falling back into his old ways. I placed him in housing and work within two weeks after the phone call.
- Two-thirds of the clients are keeping regular contact with their child. The other ones that cannot have contact are working towards making initial contact.
- Through regular contact, the clients are keeping a positive mind frame thus enabling them to avoid returning to prison.
