Body: Include the following:

- Member's name

- Request for the total amount of monthly premiums paid by the client for AC or MA-EPD services (or both)

Third, wait for a response from DHS. When DHS emails the total premium amount paid, subtract it from the MA claim total. This figure is the final MA claim amount.
